TERMS & CONDITIONS OF MEMBERSHIP

1) Member Guests

Members are able to bring guests to the health and fitness centre at a cost of \$24.00 per guest.

2) Fees

The member shall:

- (a) Pay fees in full upon signing this form
- or
- (b) Pay the joining fee upon signing this form and set up direct debit for weekly payments.

3) Direct Debit

Weekly fees are required by direct debit from your bank account. Direct Debit payment form is to be completed and signed upon application. Millbrook Resort will forward to your bank.

4) Minimum Membership Period

The Member agrees to join Millbrook Resort Health & Fitness Centre with weekly payments for a minimum period of months.

5) Termination of Membership by Member

The Member may terminate the membership of Millbrook Resort Health & Fitness Centre at any time after the expiry of the Minimum Membership Period. This needs to be in writing.

6) Suspension of Membership

No suspension of membership applies to short term members.

Ongoing Member: Must be in writing before the start date of suspension.

\$10 weekly suspension fee applies, maximum of 12 weeks per year.

7) Termination of Membership by Millbrook Resort

Millbrook Resort may terminate the Member's membership if the Member:

- (a) Fails to make payment of weekly fees on the due date.
- (b) Fails to re-join as a seasonal (six month) member.
- (c) Fails to comply with the contents of this agreement or conditions contained within the Health & Fitness Centre Information Package.

8) Joining Fees

Joining fees are payable at the commencement of the membership period and remain current as long as the membership is continuous. For seasonal (summer/winter) members, if the membership is not used each season, your membership will lapse and you will need to pay the joining fee again to re-join.

9) Suspension of Membership

Any request for suspension of membership must be in writing to Millbrook Resort.

10) Refunds / Transfers

No refunds shall apply in any circumstances and membership is not transferable.

11) Limitation of Liability

Except as provided in the Consumer Guarantee Act 1991, Millbrook Resort shall not be liable or responsible to the Member for any direct, indirect or consequential injury, loss or damage to the person or property of the member.

12) Fitness Re Assessment and Programme

An initial fitness assessment and programme is included in your start up pack for 6 month and ongoing memberships. If you require an assessment and programme, this can be scheduled with one of our fitness consultants. A \$50 fee applies for this service.
